National Research

Survey (2011) conducted by ATIA (Assistive Technology Industry Association):

- Discover attitudes of SLPs toward AT and AAC
- Assess use of AT and AAC in treatment
- Help develop strategy for improving competencies within the profession.

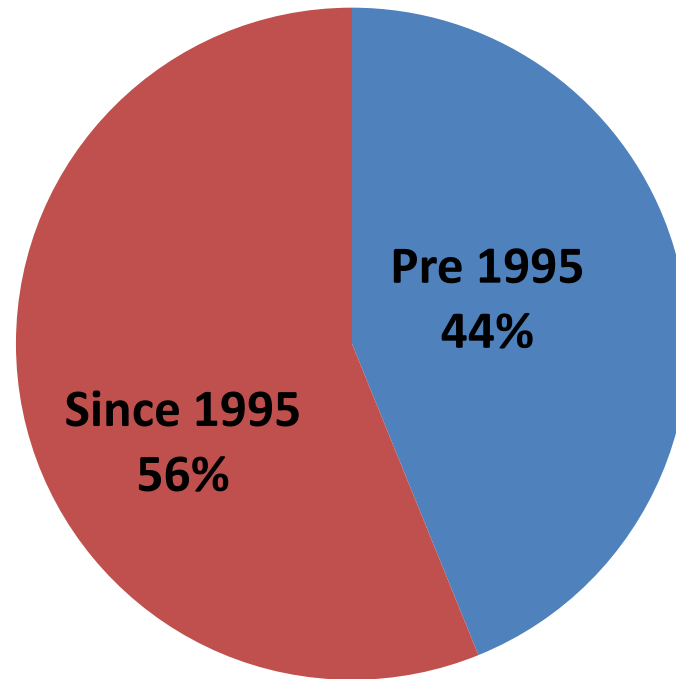

- There were 117 survey respondents.
- All were Speech-Language Pathologists in Georgia.
- Names and addresses were obtained from the State Licensure Board.
- Invitations were sent to 3780 SLPs listed on the state board roll.
- Participants were invited to answer 28 questions on Survey Monkey.
- Most questions were 5-point Likert survey questions (1-low, 5-high)
- Some questions involved ranking factors according to perceived influence.
- Opportunity for comment was provided following most questions

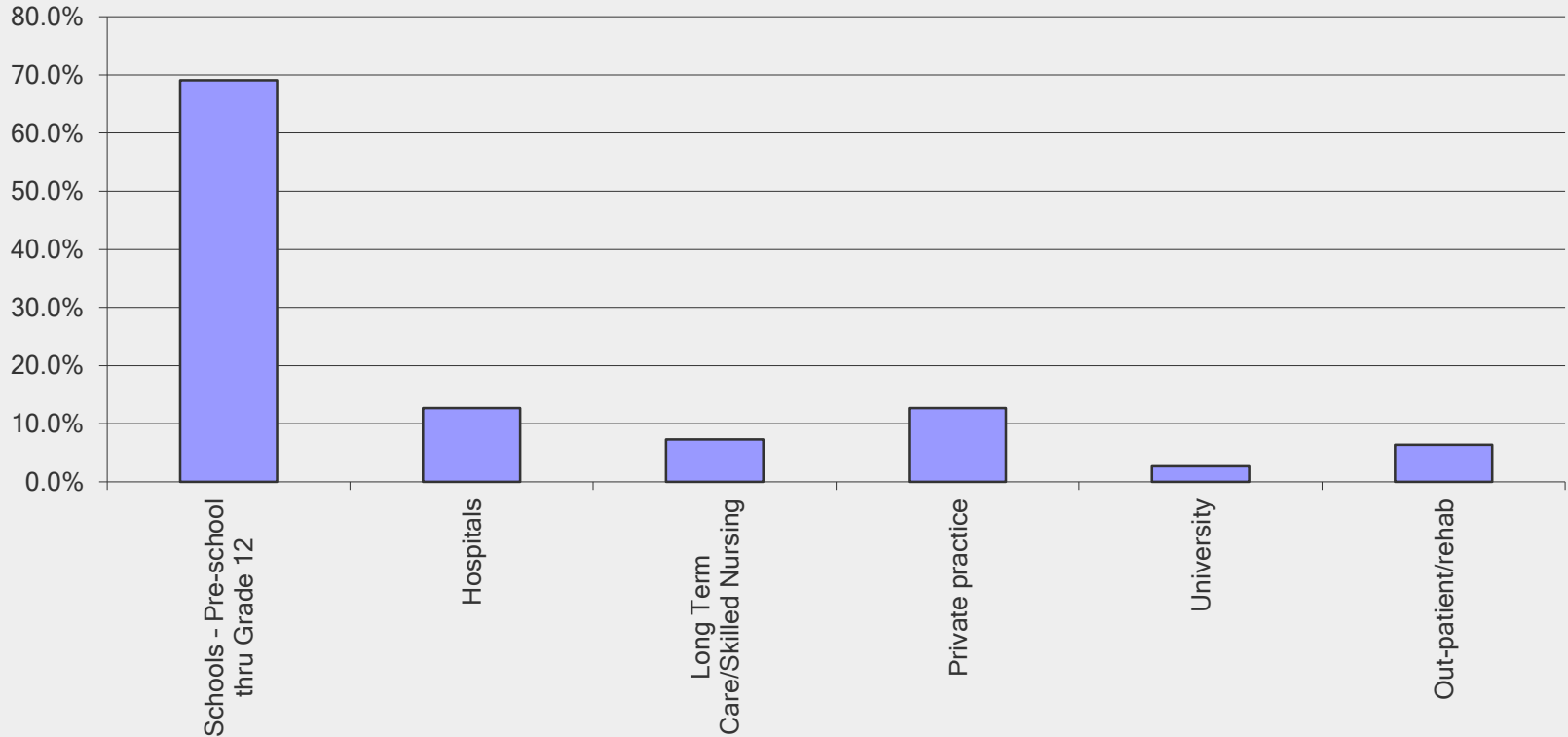

Year of Graduate Degree

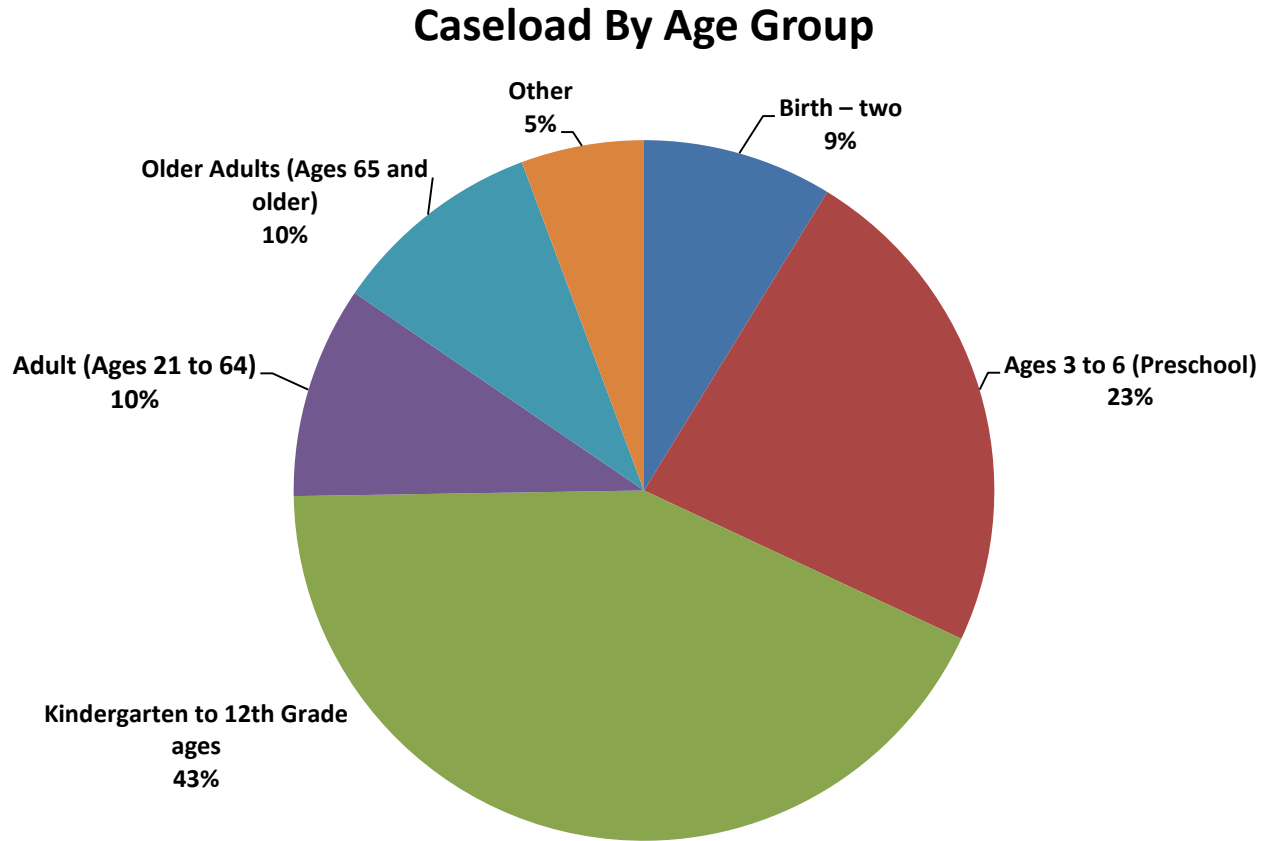


Primary Practice Setting

What is your primary practice setting?

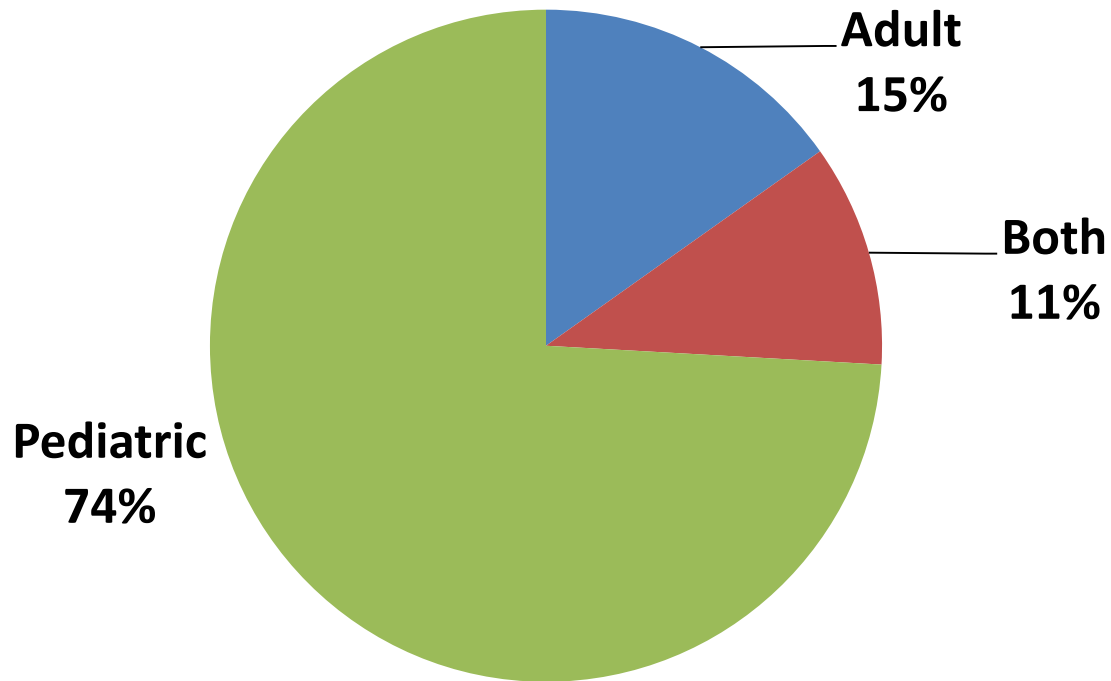


Caseload by AgeGroup

Caseload by Age Group



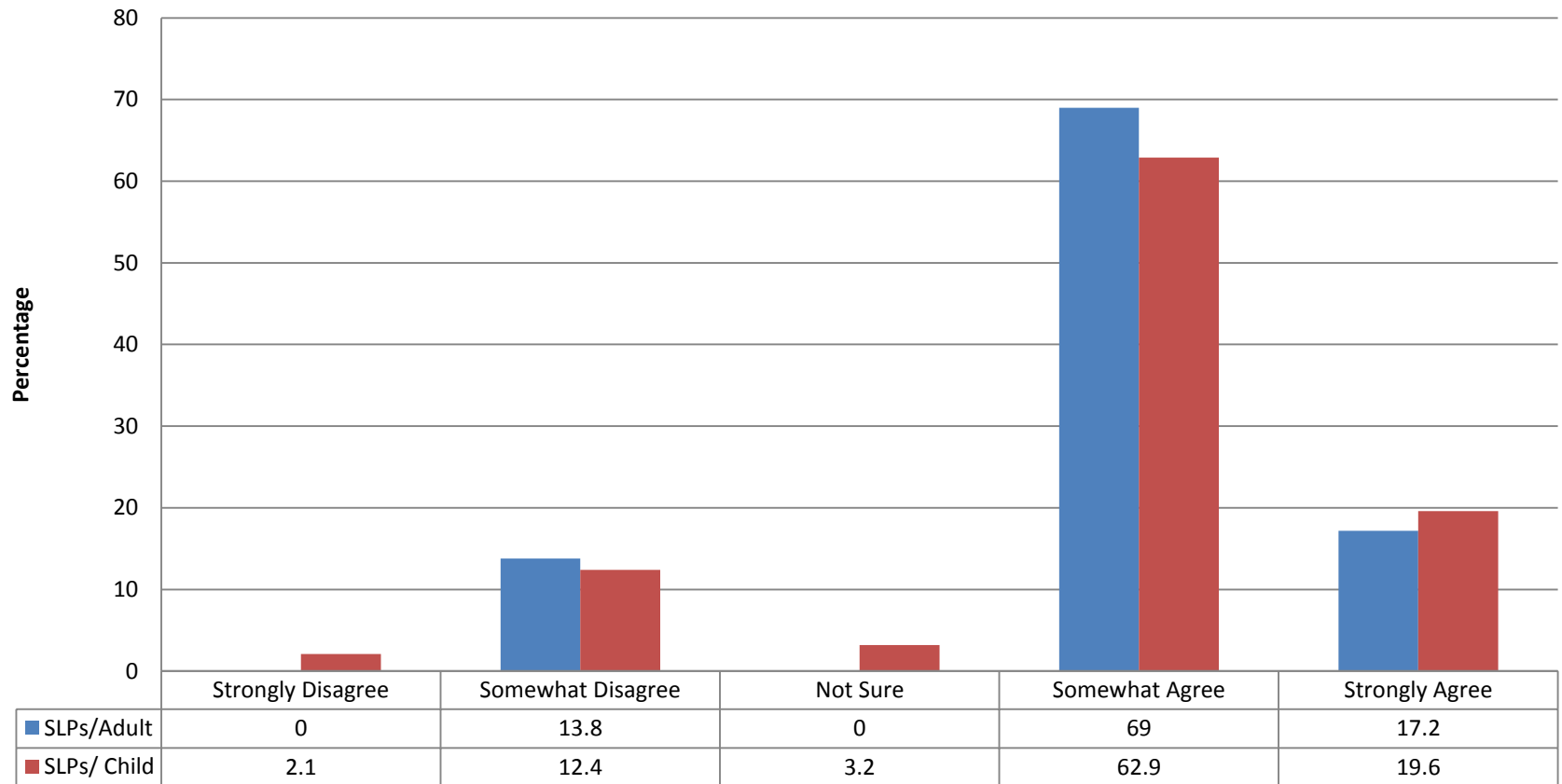

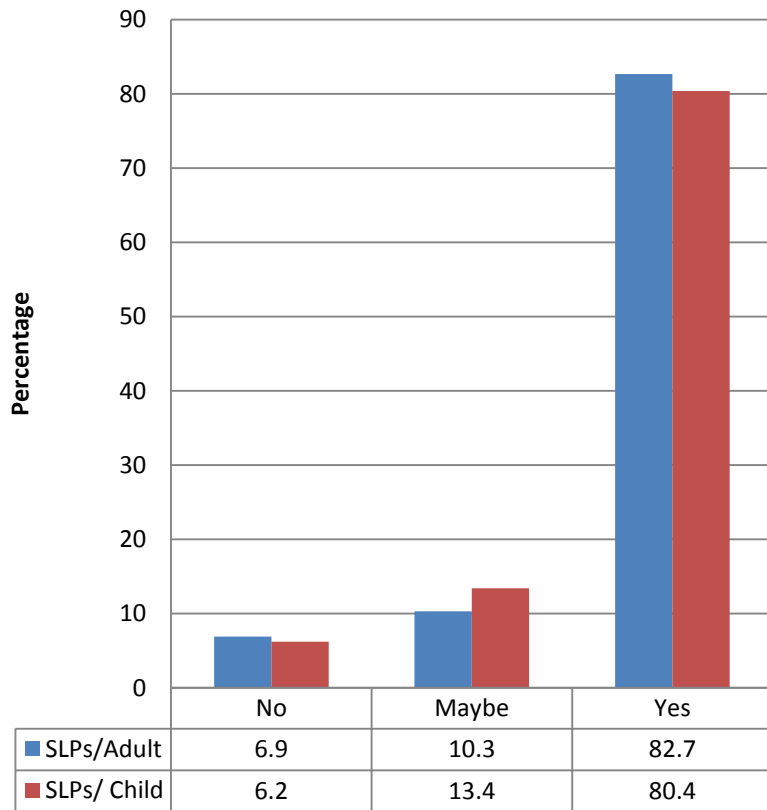
Familiarity with AAC Systems

I Am Familiar with AAC Systems...

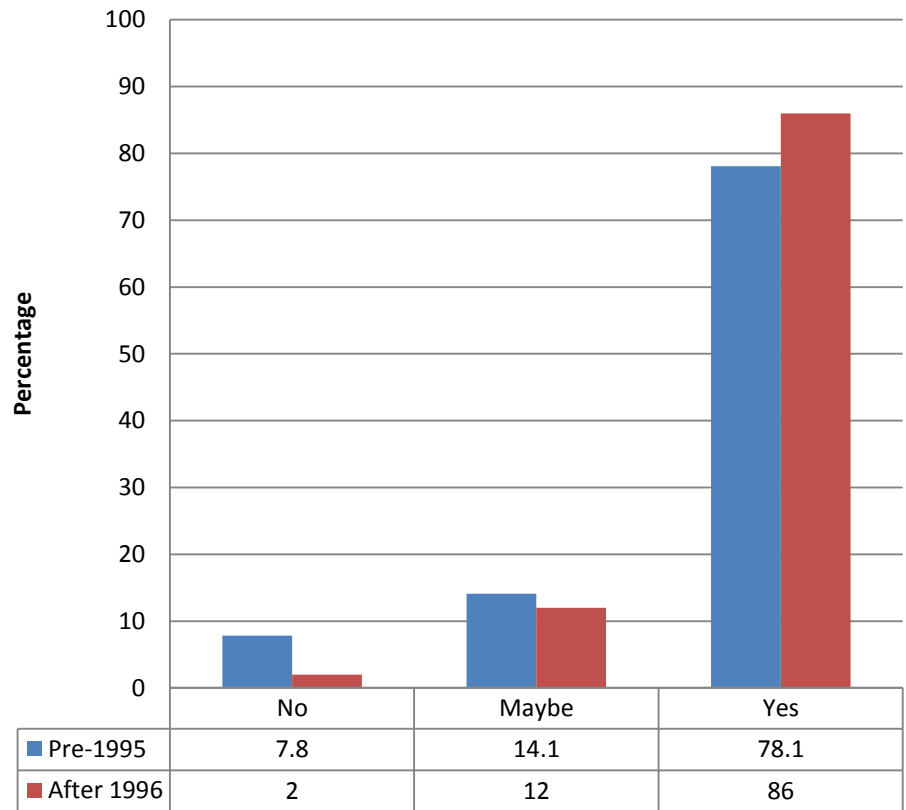

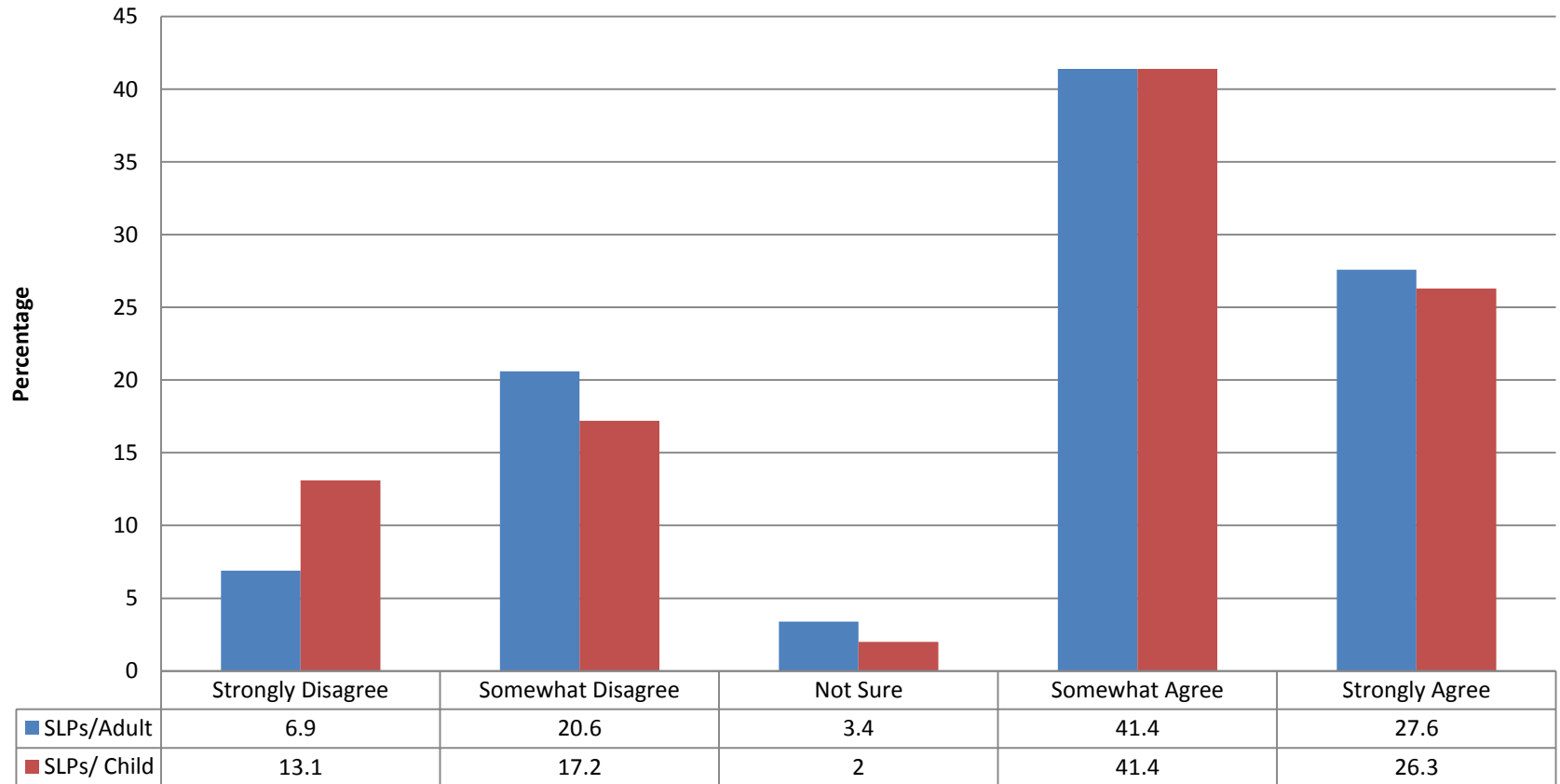

I need to learn more about how to use tablets (iPad, etc.) and apps in my clinical practice



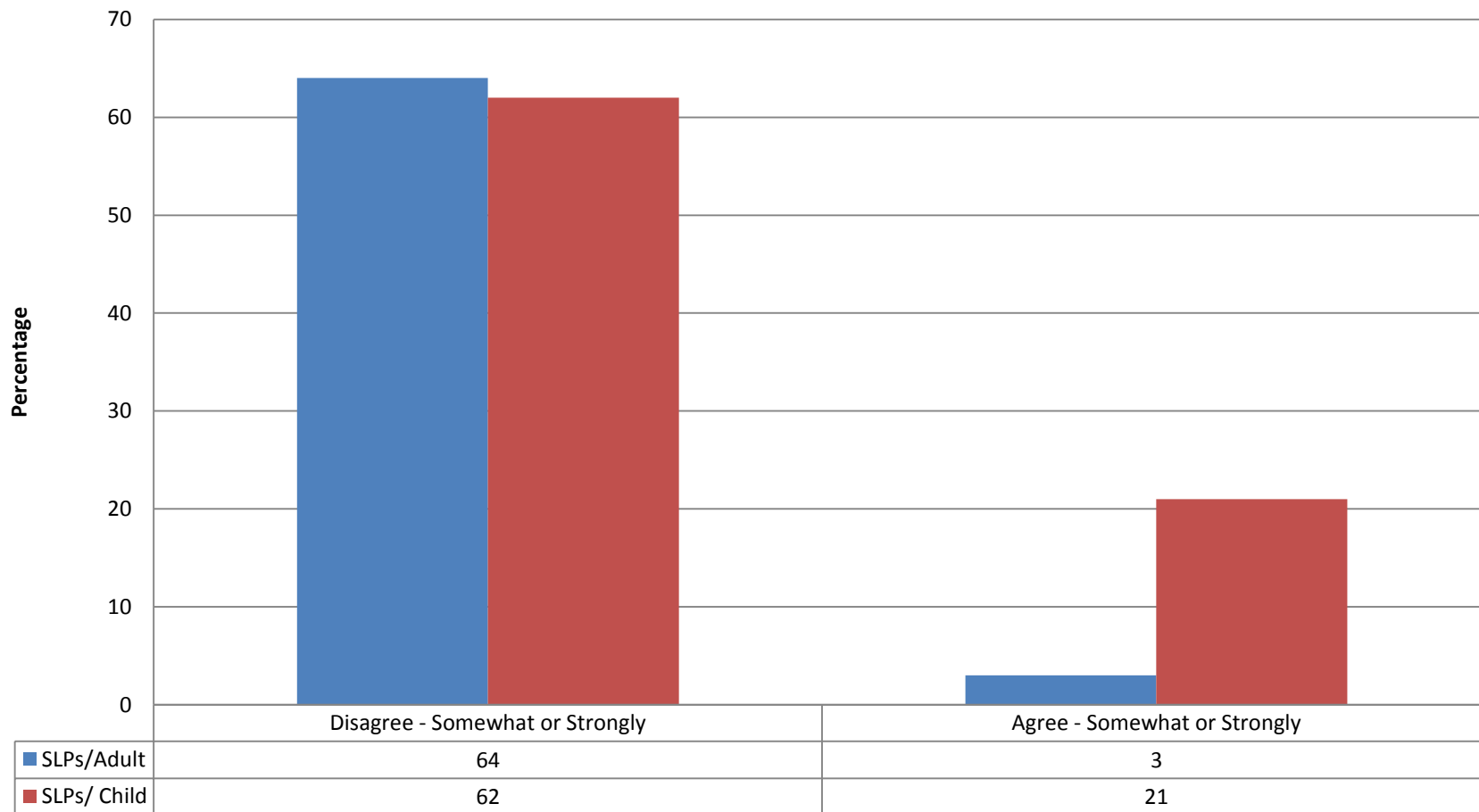


Findings

There are enough SLP's with AAC knowledge





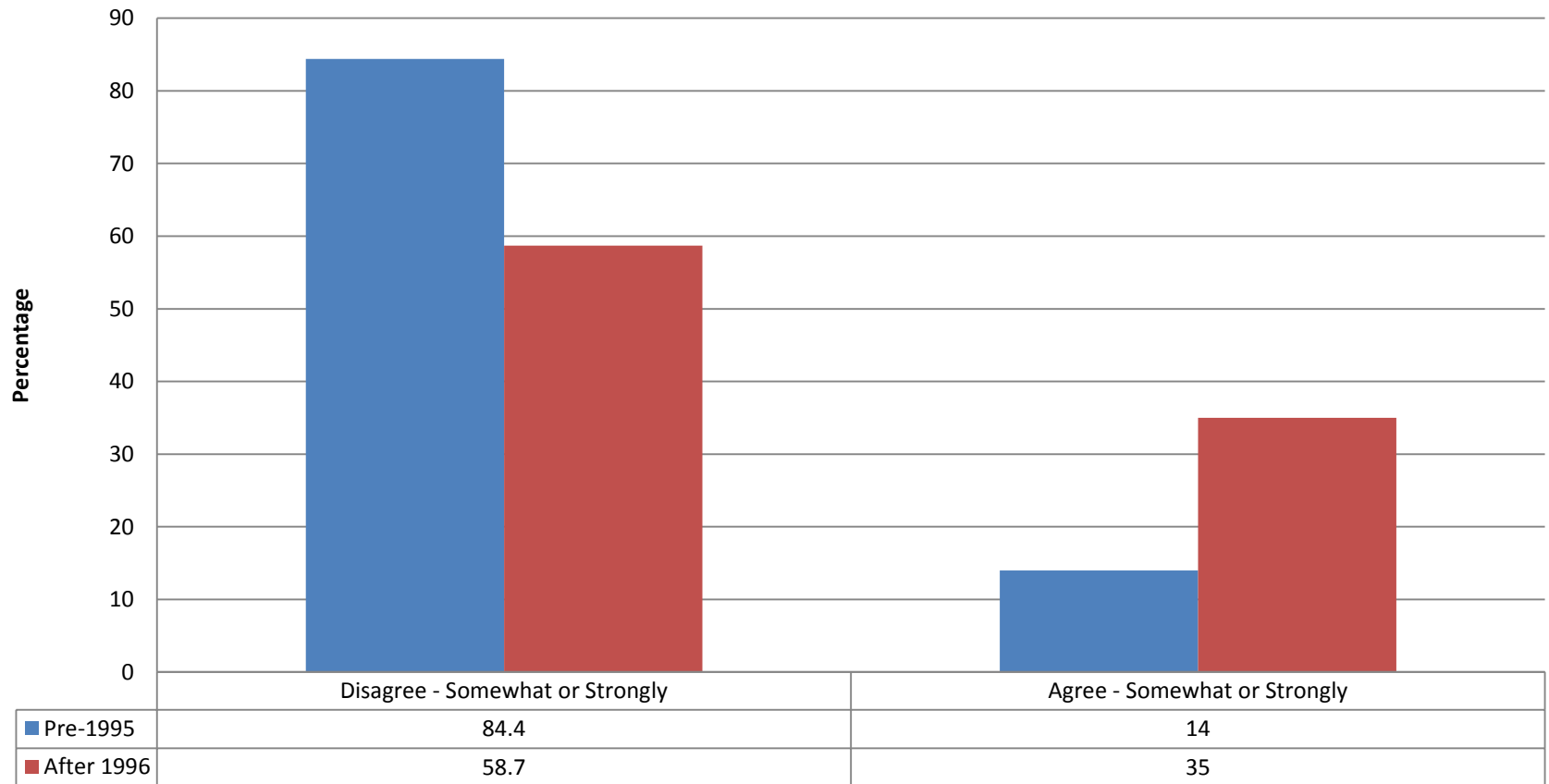
Findings

- SLPs in Georgia do not feel they have received adequate education in AT and AAC.



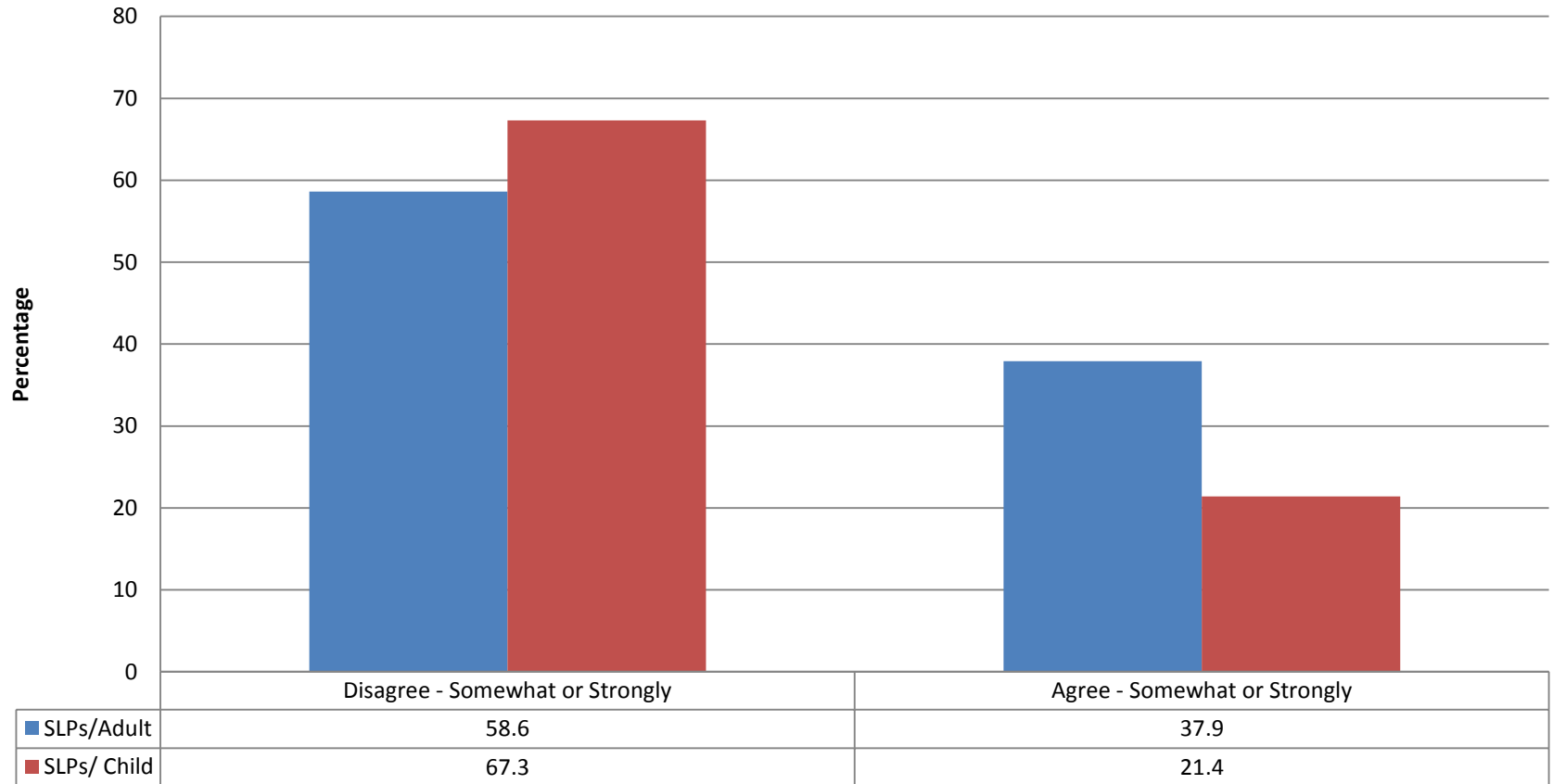
I Had Adequate Prep in AAC

I had adequate preparation in AAC (by experience).



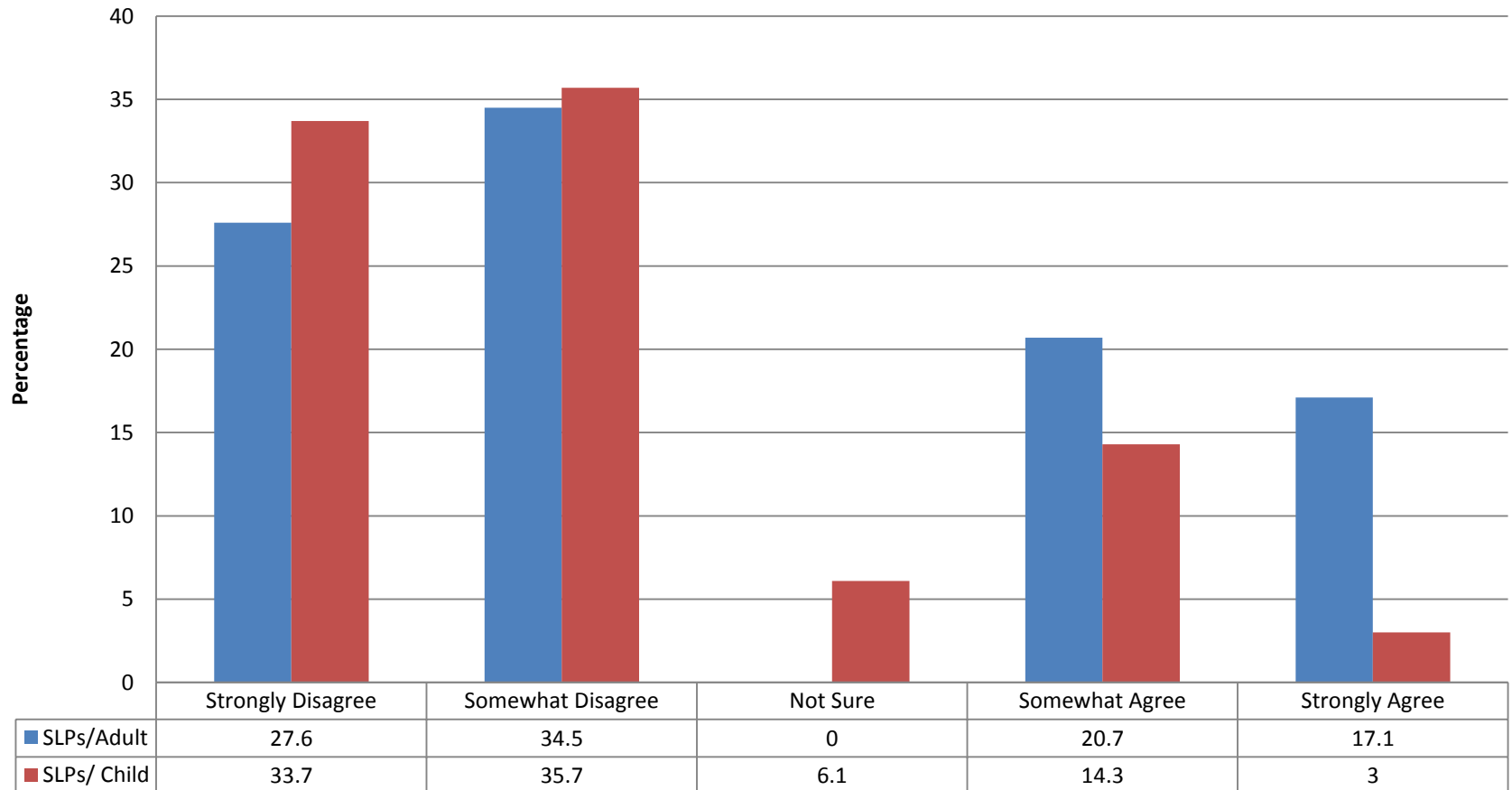
I Had Adequate Prep in AAC

Preparation in AT

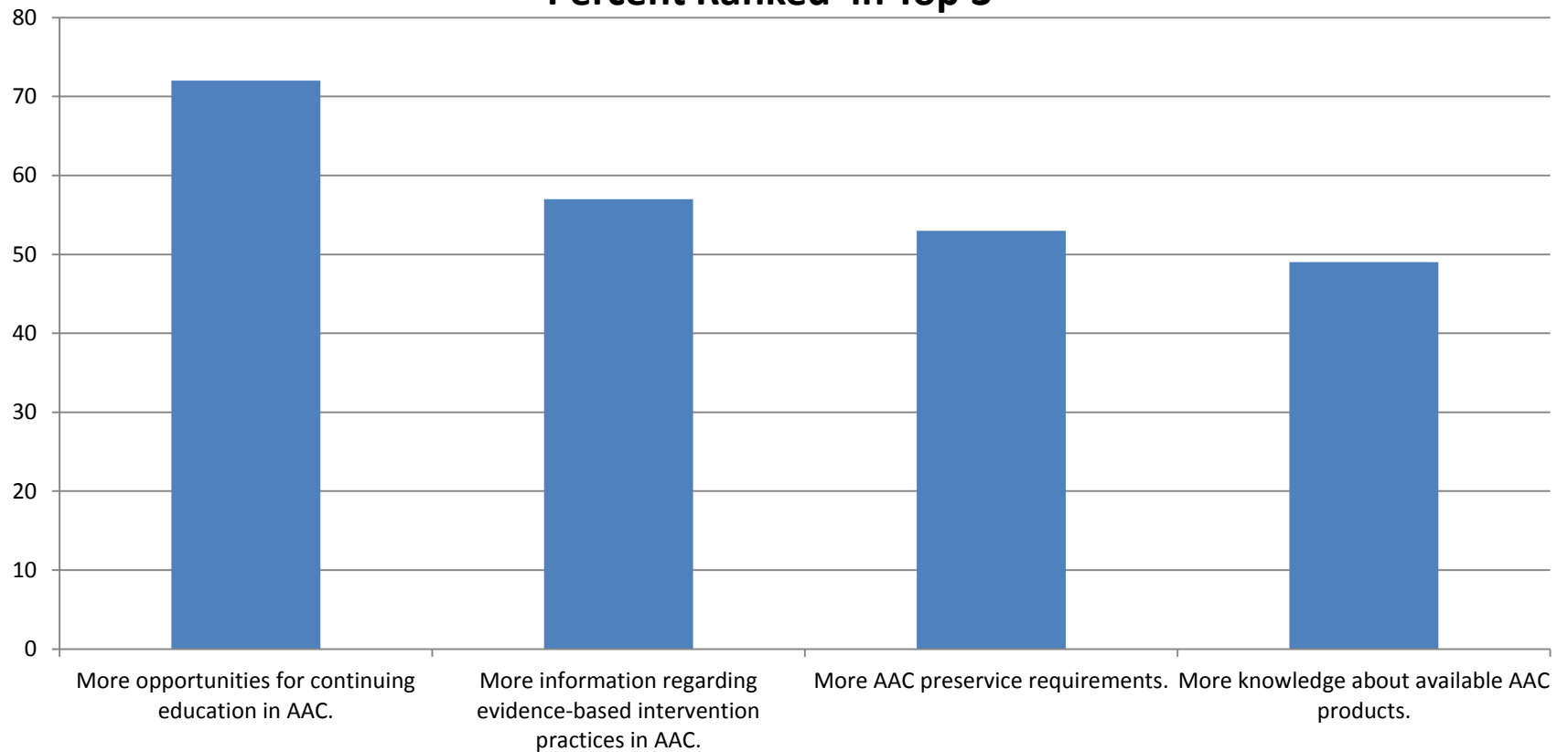
I had adequate preparation in AT (beyond AAC) in my undergraduate and/or graduate program.





Factors That Would Increase Availability of SLPs with AAC Skills

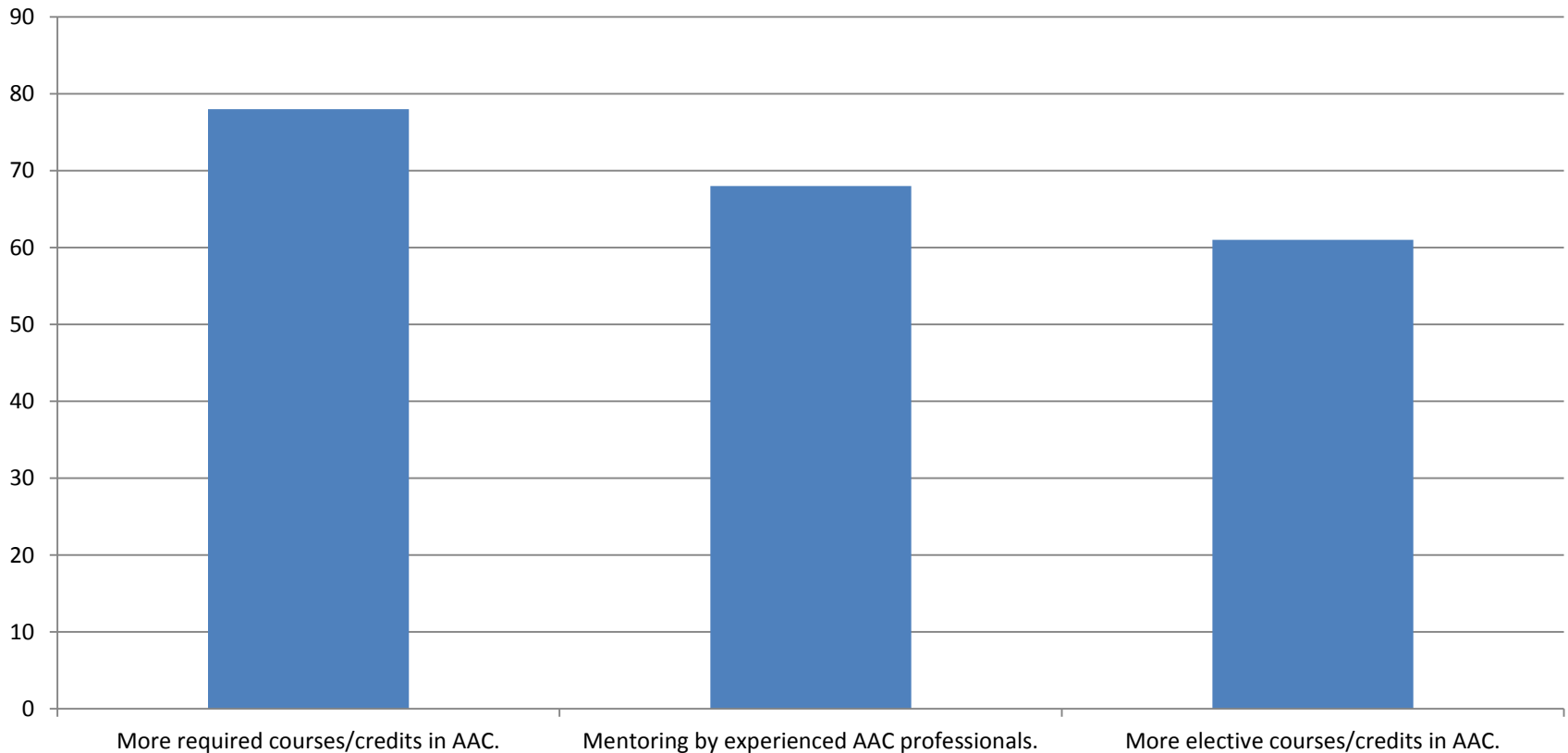
Percent Ranked in Top 3





Most Important Factors in Pre-service Ed. that Would Result in More SLPs Practicing AAC Effectively?

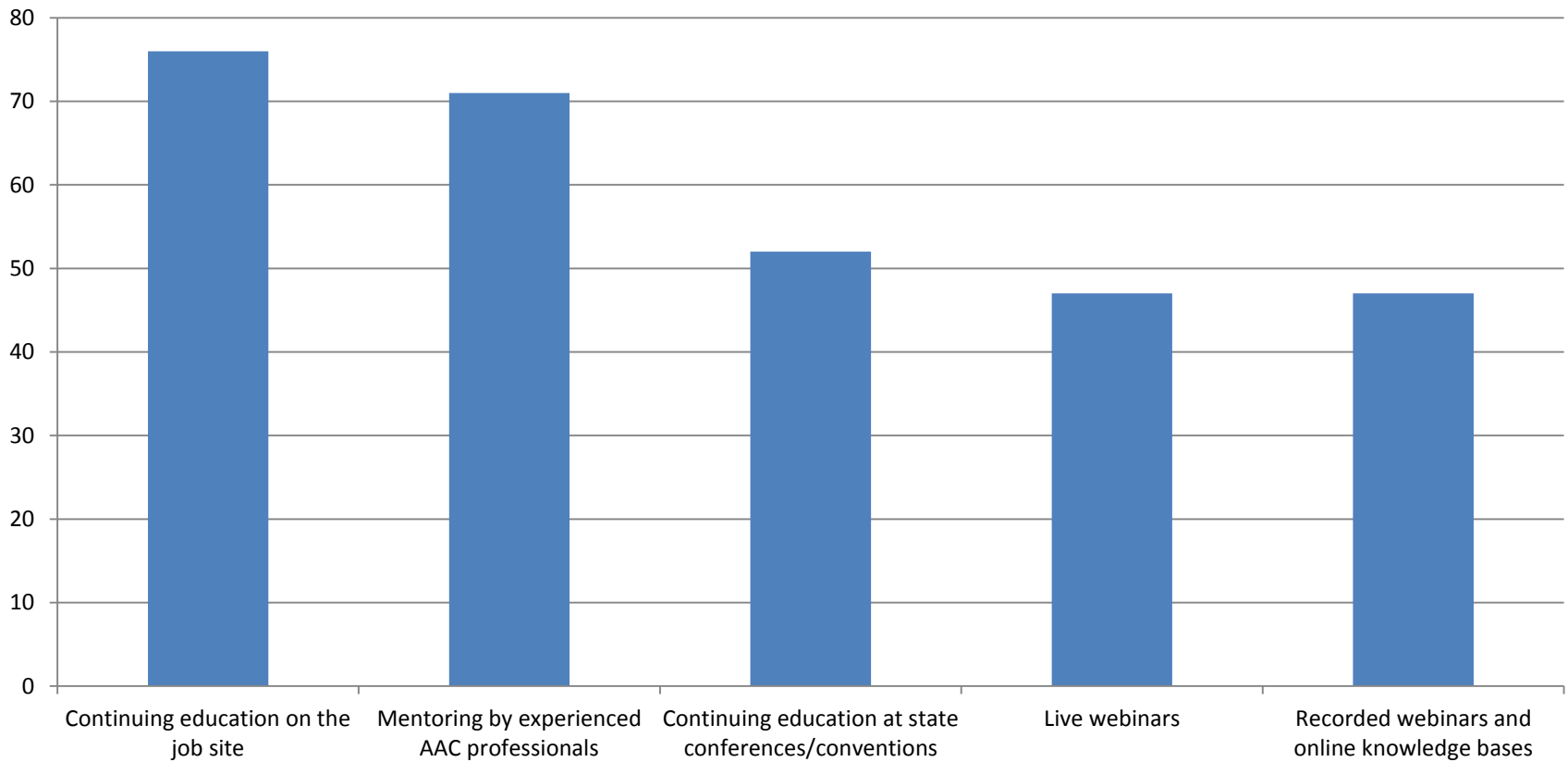
Percent Ranked in Top 3





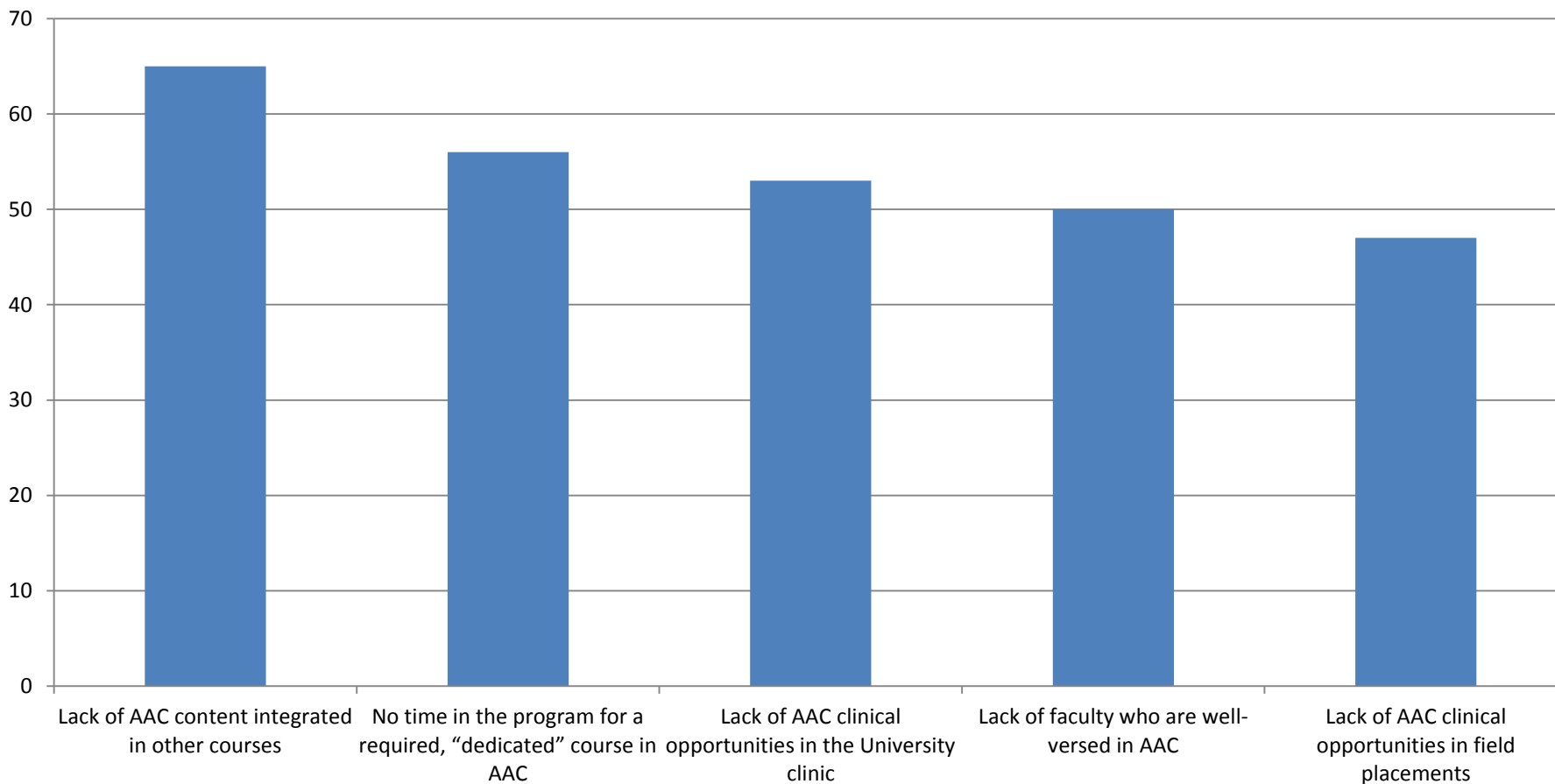
Factors that Would Enable SLPs to Become More Knowledgeable About AAC

Ranked in Top 3



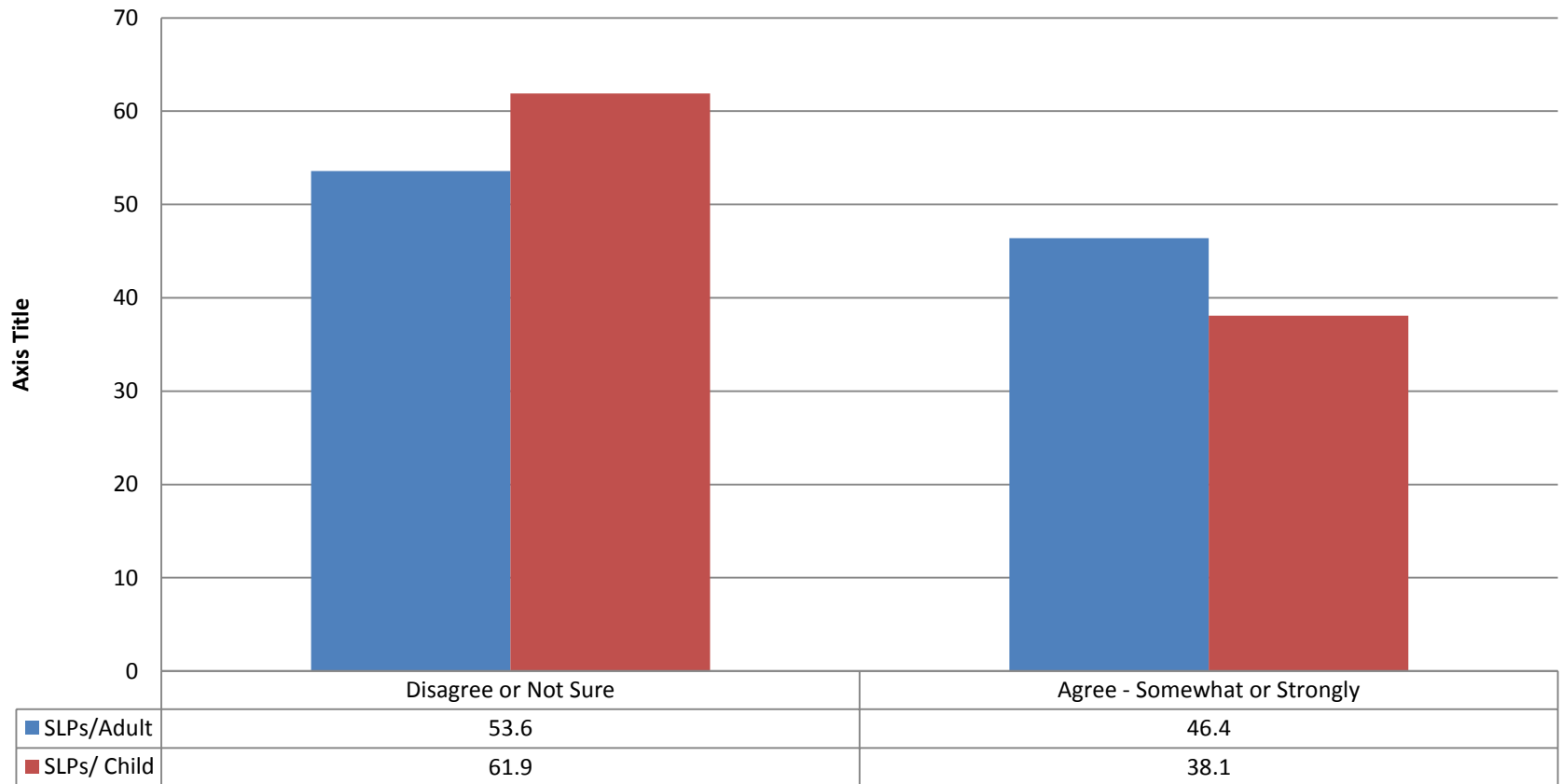


Findings

- SLPs point to a lack of consistency in SLP delivery of AT and AAC services

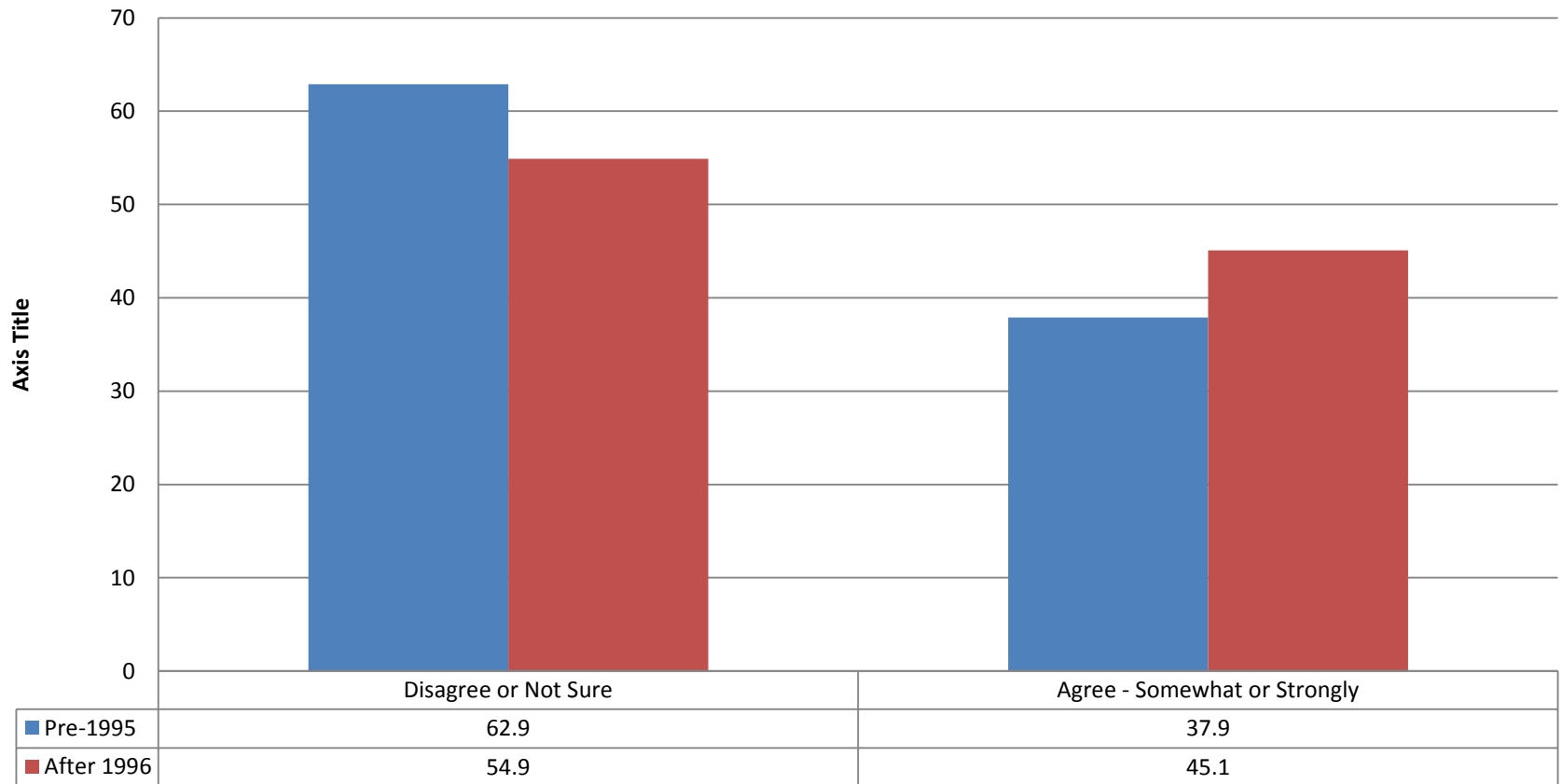
SLPs Know AAC Strategies

SLPs are Knowledgeable About AAC Intervention Strategies



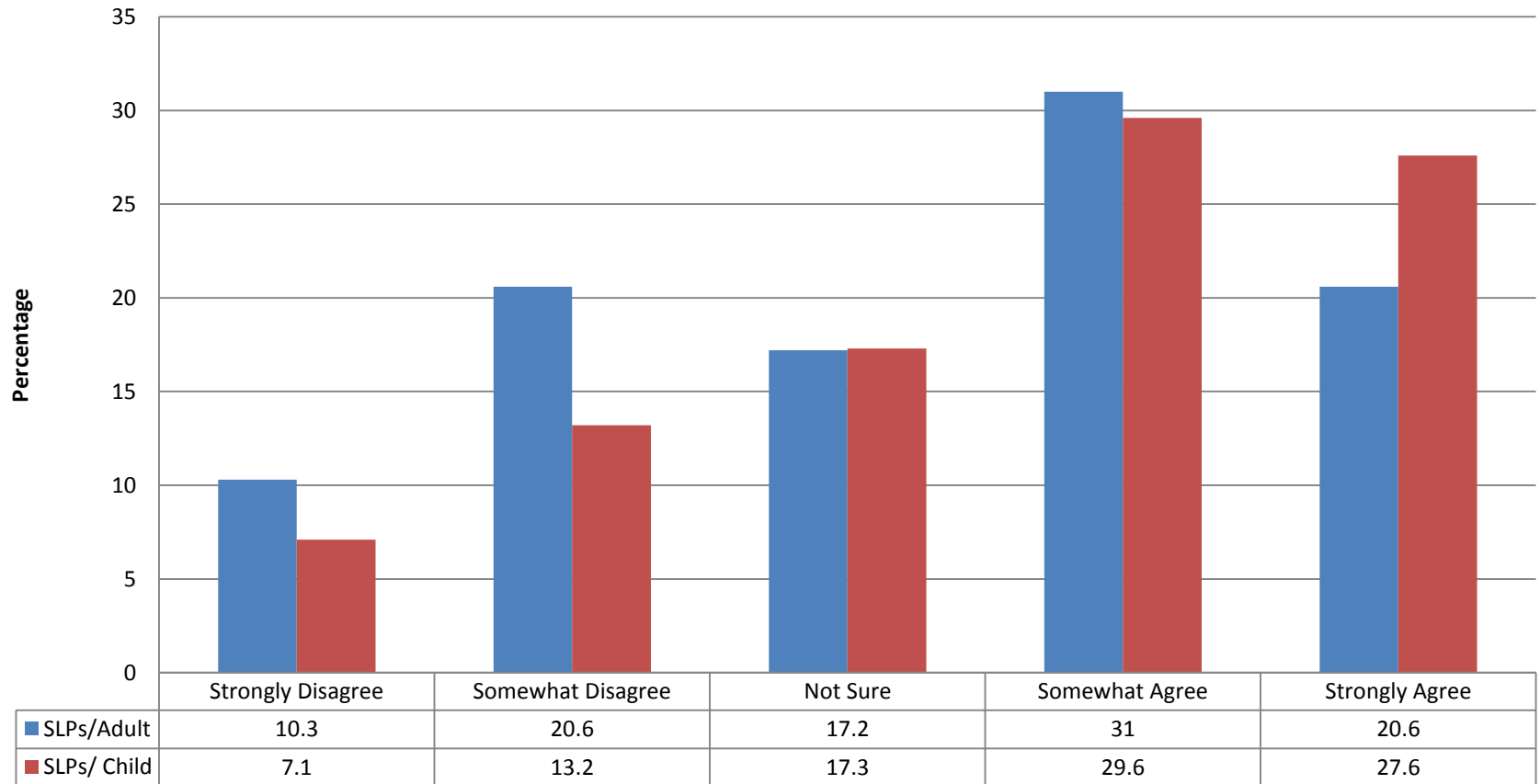

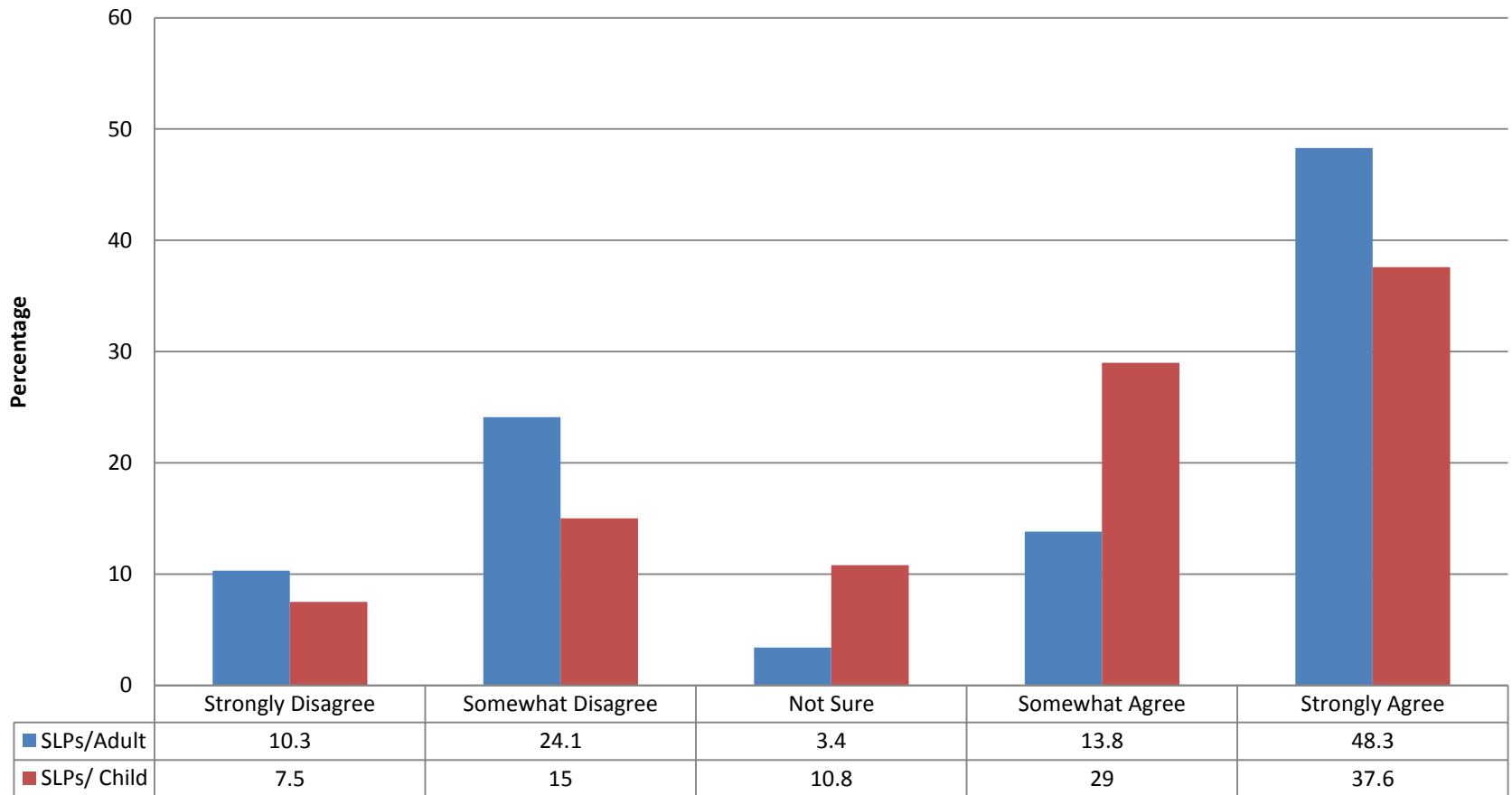
SLPs Familiar with Definitions of AT

Respondents familiar with the IDEA 2004 definition of AT Devices & Services



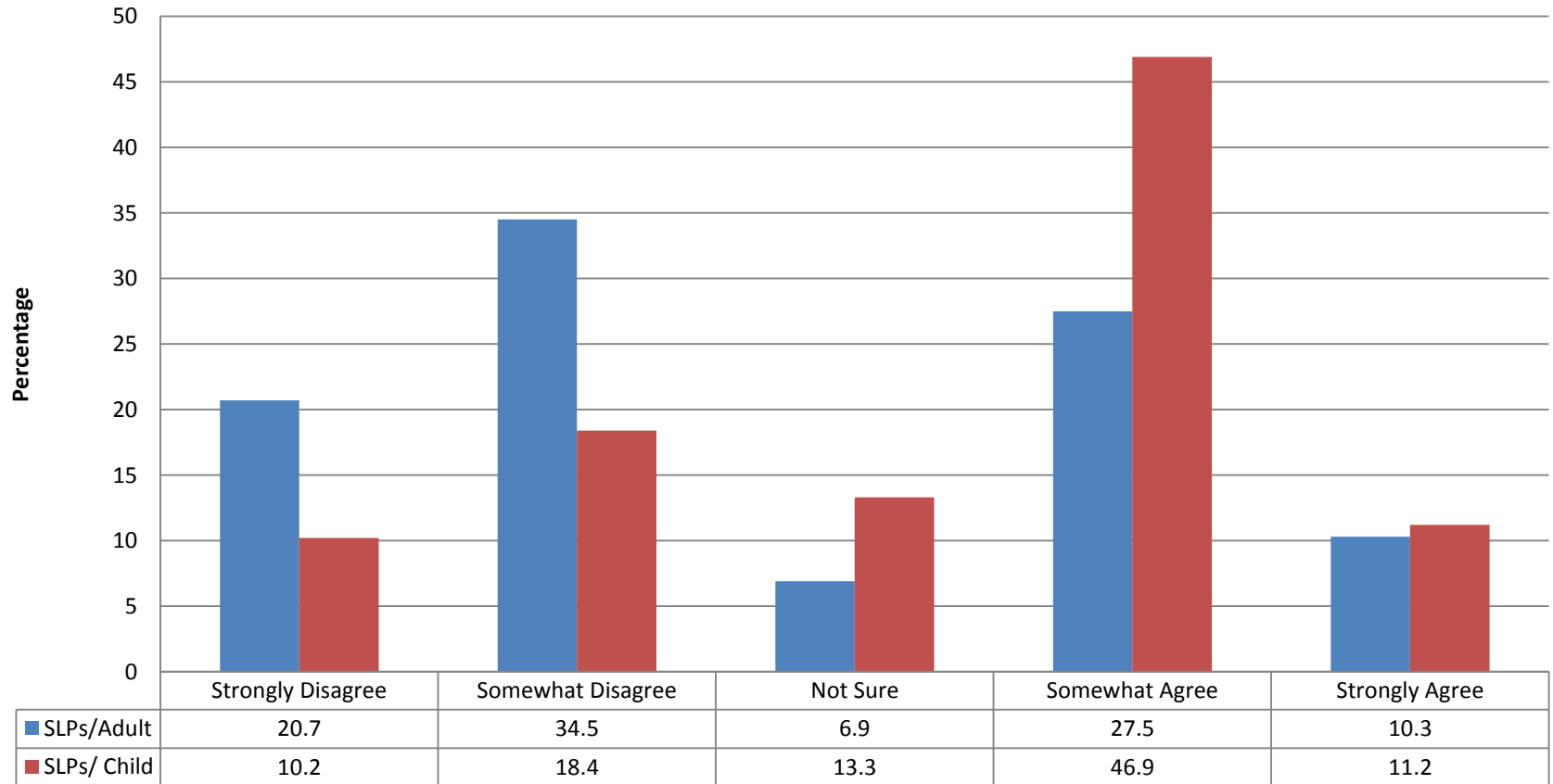
Accessibility Awareness

I am familiar with the requirements that all (not just blind) students who have print disabilities must have access to print instructional materials in an accessible format, free of charge.



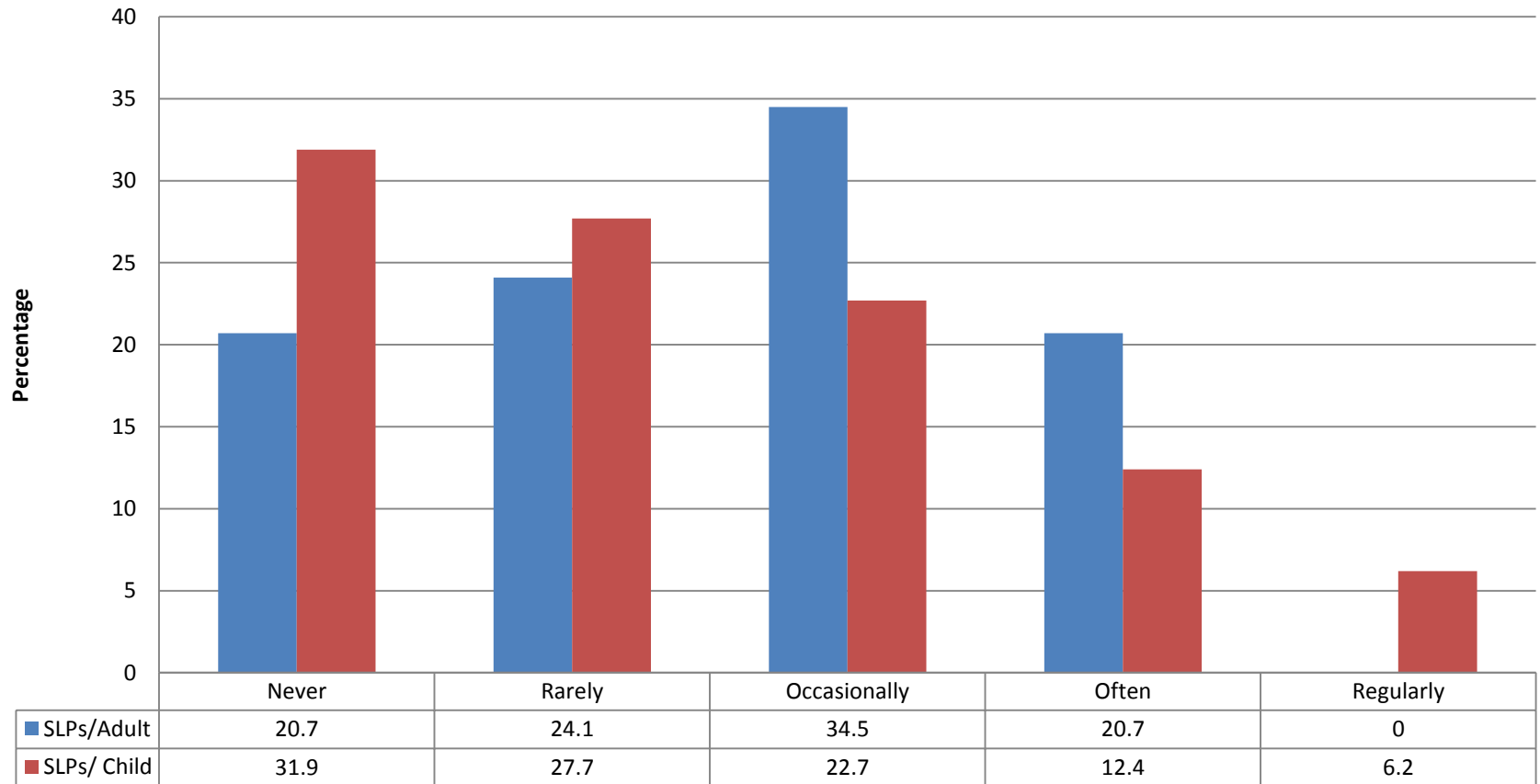

I am familiar with AT tools for adapting curriculum.



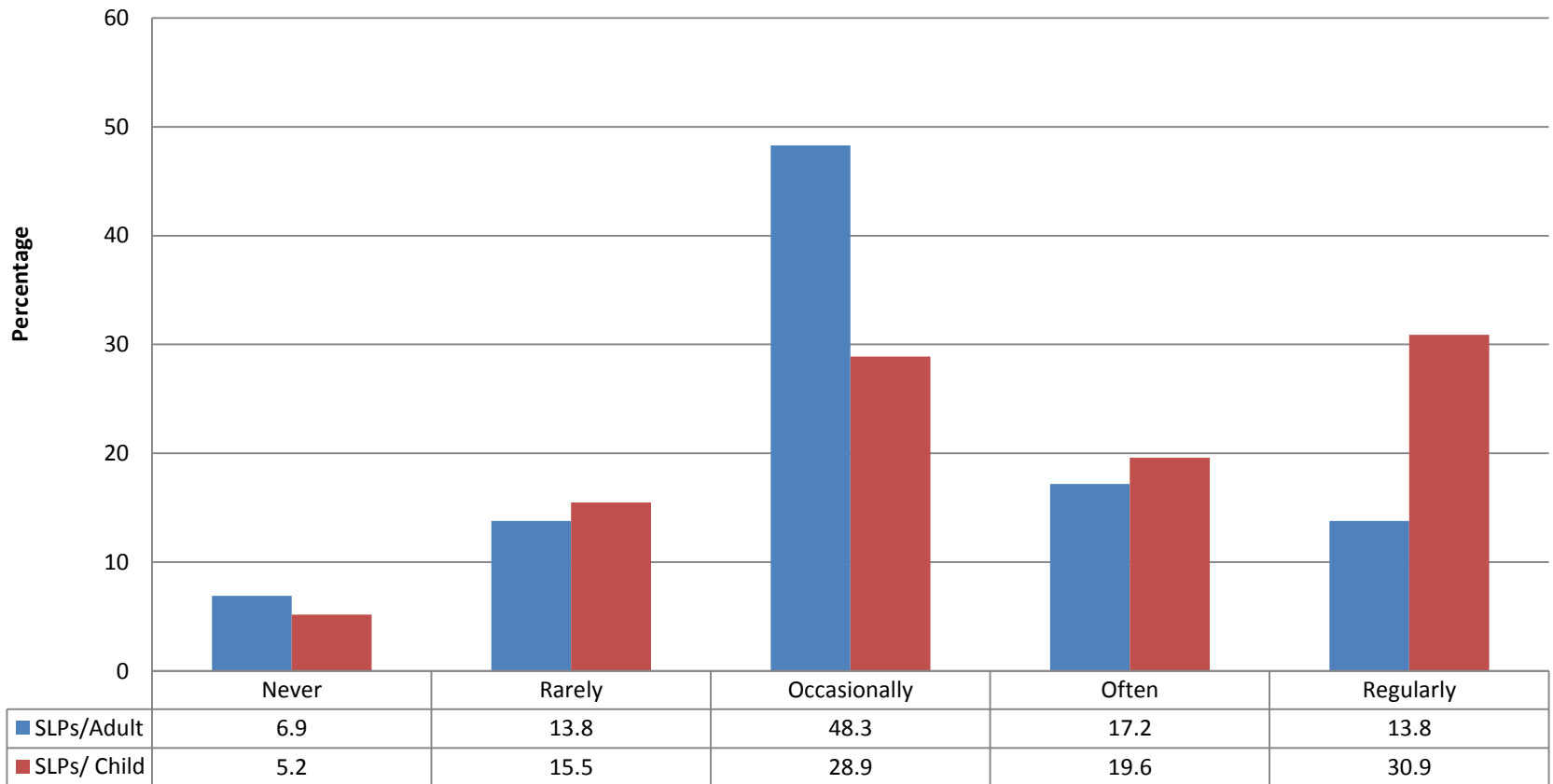

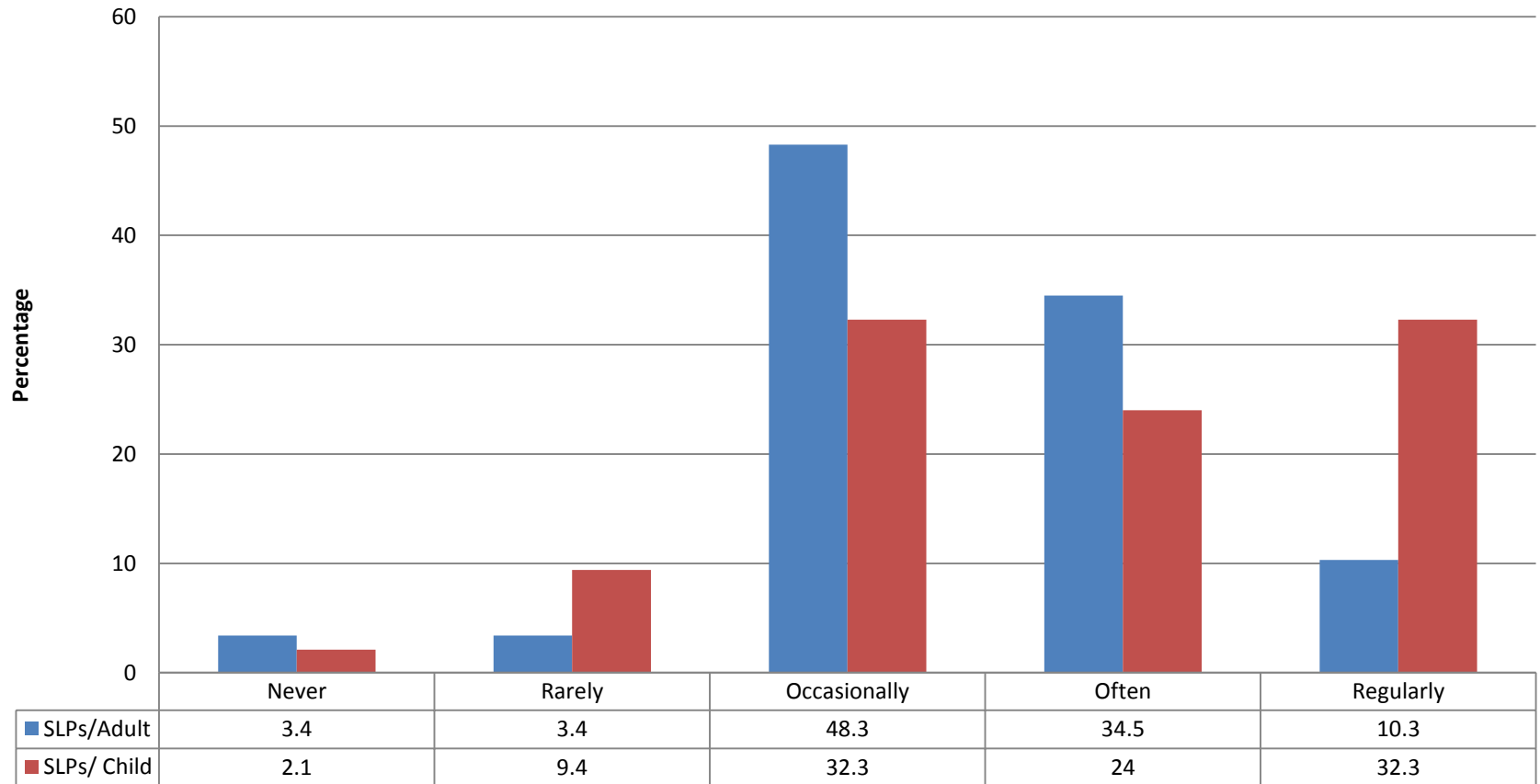

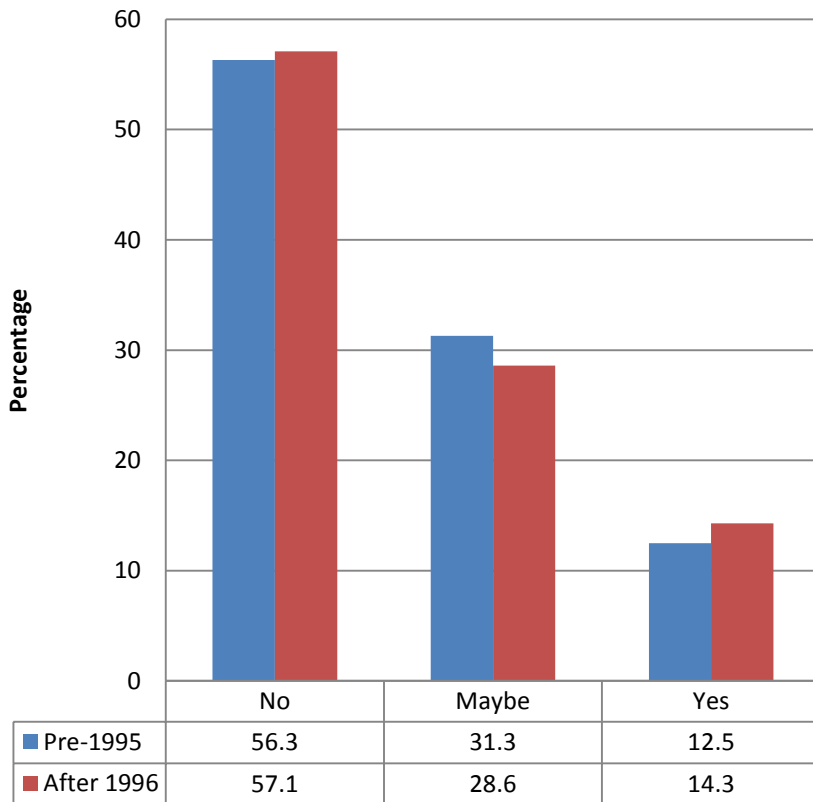

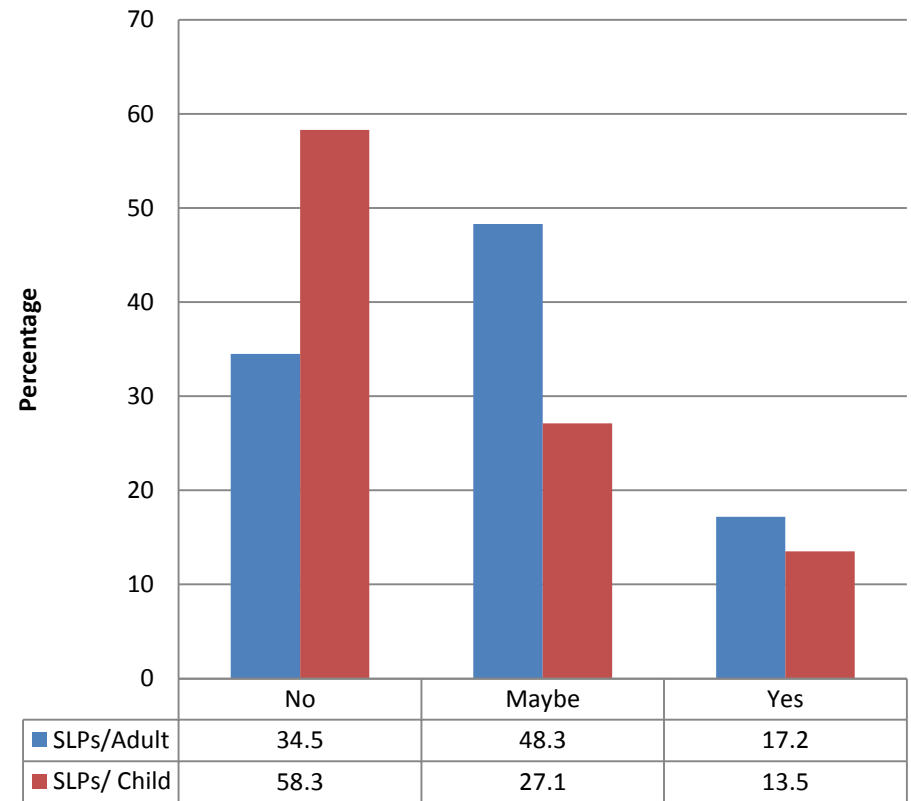

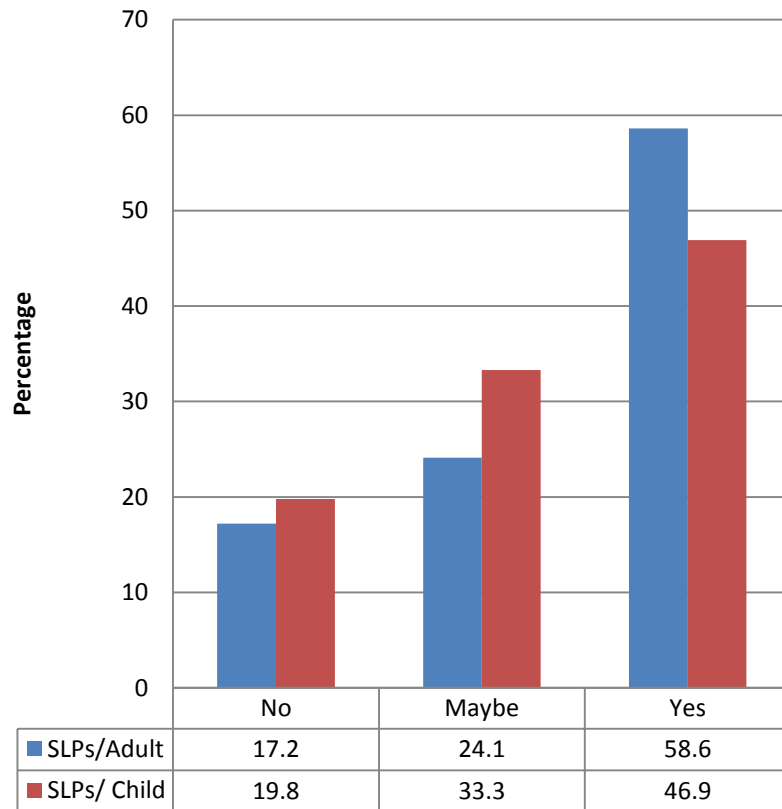

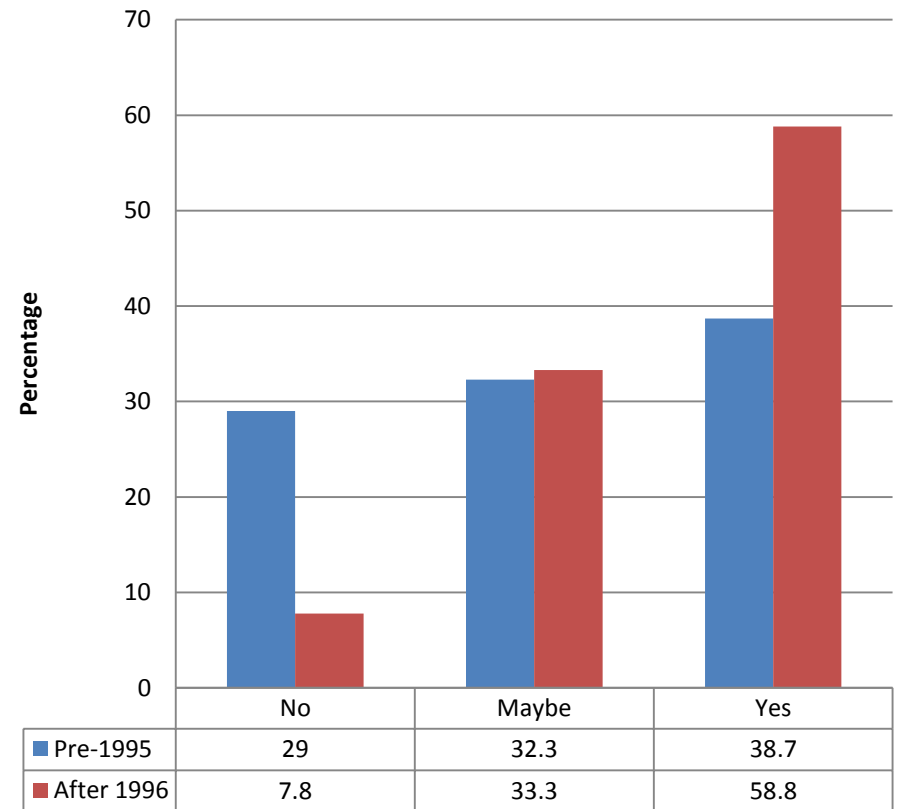
